The Group Board is responsible for setting 'tone from the top'. It is committed to ensuring PIB

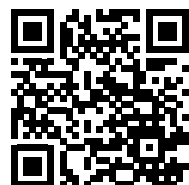
operates within a strong moral compass and that PIB truly lives up to always Doing the Right Thing as set out in our Code of Conduct and our policies.
